RULES:

Light oil permitted. No bottles of tanning lotion are allowed in the building. Please have your tanning preparation done before you arrive.

Any competitor who competes in prejudging must participate in the evening show.

Solid color posing suits only. (no T-back or thong suits allowed). No jewelry will be worn (except wedding rings). Ladies may wear earrings, hair ornaments at the evening show.

POSING

Evening show 60 seconds of individual posing with music.

At check-in, each competitor must provide a cassette tape (high bias) or CD with the posing music taped at the beginning, cued to start at the beginning of the tape. If cassette is broken, not cued, etc., we will automatically install a "house tape". **Any competitor's music that contains profanity or vulgarity will be disqualified.**

ELIGIBILITY:

Each competitor must be currently registered with the NPC (National Physique Committee) and to meet this requirement, he/she must present his/her current NPC card or receipt, or you may purchase an NPC card at this competition (\$100.00)

All athletes must exhibit good sportsmanship at all times (including award presentation).

No one will be allowed backstage or in the pump-up room except competitors and contest officials. Current NPC rules will apply.

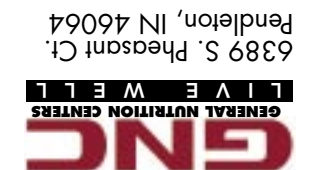

 No crossover from women's bodybuilding or bikini to figure. No crossover from men's physique to bodybuilding.

Awards: The top five athletes in each class plus overall novice, figure, men's and women's winners will be awarded trophies.

Music: Cassette tape or CD is acceptable. Each tape cassette must contain only one track, must be pre-set, must be limited to 60 seconds and must bear the contestant's name. Each contestant is responsible for picking up their music after the evening show. No profanity or vulgarity will be allowed.

Posing: No free posing during prejudging, 60 second limit to routines at evening show.

Entry Fee: make check or money order for \$50 payable to Dave Cravens. Crossovers complete a separate entry form for each division and include a \$25 additional entry fee for each division. Send to Dave Cravens, 6389 Pheasant Ct., Pendleton, IN 46064.

Deadline: Entries will be accepted day of show. All entries not received by Saturday May 26th will have an additional \$15 late charge.
